

## Keensight Capital strengthens its team with the appointments of Arjan Hannink as Director and Léa Najmark as Analyst

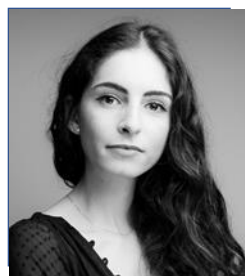
